Terms and Conditions for

Online-Payments

The Terms and Conditions contained herein shall apply to any person ("User") using the services ofM/s. KalyanResorts for making Hotel Booking and allied services payments through an onlinepayment gateway service ("Service") offered by M/s.Kalyan Resorts for our Hotel Miramar in association with Axis Bank Pvt. Ltd. through M/s. Kalyan Resorts website i.e. http://www.hotelmiramar.in ("Website"). Each User is therefore deemed to have read and accepted these Terms and Conditions.

A. Privacy Policy

M/s.Kalyan Resorts respects and protects the privacy of the individuals that access theinformation and use the services provided through them. Individually identifiable information about the User is not willfully disclosed to any third party without first receiving the User's permission, ascovered in this Privacy Policy.

This Privacy Policy describes M/s.Kalyan Resorts treatment of personally identifiableinformation that M/s.Kalyan Resorts collects when User is on the M/s.Kalyan ResortswebsiteM/s.Kalyan Resorts does not collect any unique information about the User (such asUser's name, email address, age, gender etc.) except when the User specifically and knowinglyprovide such information on the Website. Like any business interested in offering the highest quality ofservice to clients, M/s.Kalyan Resorts may, from time to time, send email and othercommunication to the User tell them about the various services, features, functionality and contentoffered by M/s.Kalyan Resorts website or seek voluntary information from you.

Please be aware, however, that M/s.Kalyan Resorts will release specific personal informationabout the User if required to do so in the following circumstances:

- a) In order tocomply with any valid legal process such as a search warrant, statute, or court order, or
- b)If any of User's actions on M/s.Kalyan Resorts website violate the Terms of Service orany of M/s.Kalyan Resorts guidelines for specific services, or
- c) To protect or defend M/s.Kalyan Resorts legal rights or property,M/s.Kalyan Resorts site, or M/s.Kalyan Resorts Users; or
- d) To investigate, prevent, or take action regarding illegal activities, suspected fraud, situations Involving potential threats to the security, integrity of M/s.Kalyan Resorts website/offerings.
- B. General Terms and Conditions For Online-Payments
- 1. Once a User has accepted these Terms and Conditions, he/ she may register and avail the Services. A User may either register M/s. Kalyan Resorts website or alternativelyenter [his/ her consumer number and billing unit number and pay their hotel bills / dues/ bill(s) or]" please change this clause as per the

type of payment associated with thisclient" in any other manner as may be specified M/s.Kalyan Resorts from time to time.

- 2. M/s.Kalyan Resorts rights, obligations, undertakings shall be subject to the laws in forcein India, as well as any directives/ procedures of Government of India, and nothing contained in These Terms and Conditions shall be in derogation of M/s.Kalyan Resorts right to complywith any law enforcement agencies request or requirements relating to any User's use of thewebsite or information provided to or gathered by M/s.Kalyan Resorts with respect to suchuse. Each User accepts and agrees that the provision of details of his/ her use of the Websiteto regulators or police or to any other third party in order to resolve disputes or complaintswhich relate to the Website shall be at the absolute discretion of M/s.Kalyan Resorts.
- 3. If any part of these Terms and Conditions are determined to be invalid or unenforceablePursuant to applicable law including, but not limited to, the warranty disclaimers and liabilityLimitations set forth herein, and then the invalid or unenforceable provision will be deemedSuperseded by a valid, enforceable provision that most closely matches the intent of theOriginal provision and the remainder of these Terms and Conditions shall continue in effect.
- 4. These Terms and Conditions constitute the entire agreement between the User and M/s.Kalyan Resorts. These Terms and Conditions supersede all prior or contemporaneousCommunications and proposals, whether electronic, oral, or written, between the User andM/s.Kalyan Resorts. A printed version of these Terms and Conditions and of any noticegiven in electronic form shall be admissible in judicial or administrative proceedings basedupon or relating to these Terms and Conditions to the same extent and subject to the sameconditions as other business documents and records originally generated and maintained inprinted form.
- 5. The entries in the books of M/s.Kalyan Resortsand/or the Payment Service Providerskept in the ordinary course of business of M/s.Kalyan Resortsand/or the Payment ServiceProviders with regard to transactions covered under these Terms and Conditions and mattersTherein appearing shall be binding on the User and shall be conclusive proof of theGenuineness and accuracy of the transaction.
- 6. Refund for Charge Back Transaction: In the event there is any claim for/ of charge back byThe User for any reason whatsoever, such User shall immediately approach M/s.Kalyan Resortswith his/ her claim details and claim refund M/s.Kalyan Resortsalone. Suchrefund (if any) shall be effected only by M/s.Kalyan Resortsvia payment gateway or bymeans of a demand draft or such other means as M/s.Kalyan Resortsdeems appropriate.No claims for refund/ charge back shall be made by any User to the Payment ServiceProvider(s) and in the event such claim is made it shall not be entertained.
- 7. In these Terms and Conditions, the term "Charge Back" shall mean, approved and settledcredit card or net banking purchase transaction(s) which are at any time refused, debited orcharged back to merchant account (and shall also include similar debits to Payment Service Provider's accounts, if any) by the acquiring bank or credit card company for any reasonwhatsoever, together with the bank fees, penalties and other charges incidental thereto.

- 8. Refund for fraudulent/duplicate transaction(s): The User shall directly contact M/s.Kalyan Resortsfor any fraudulent transaction(s) on account of misuse of Card/ Bank details by aFraudulent individual/party and such issues shall be suitably addressed M/s.Kalyan Resortsalone in line with their policies and rules.
- 9. Server Slow Down/Session Timeout: In case the Website or Payment Service Provider'swebpage, that is linked to the Website, is experiencing any server related issues like 'slowdown' or 'failure' or 'session timeout', the User shall, before initiating the second payment, check whether his/her Bank Account has been debited or not and accordingly resort to one ofthe following options:
- (I) In case the Bank Account appears to be debited, ensure that he/ she does not make thepayment twice and immediately thereafter contact M/s.Kalyan Resorts via e-mail or another mode of contact as provided by M/s.Kalyan Resortsto confirm payment.

(ii)in case the Bank Account is not debited, the User may initiate a fresh transaction to makepayment.

However, the User agrees that under no circumstances the Payment Gateway ServiceProvider shall be held responsible for such fraudulent/duplicate transactions and hence noclaims should be raised to Payment Gateway Service Provider No communication received bythe Payment Service Provider(s) in this regards shall be entertained by the Payment ServiceProvider(s).

C. Limitation of Liability

- 1. M/s.Kalyan Resortshas made this Service available to the User as a matter ofconvenience.M/s.Kalyan Resortsexpressly disclaims any claim or liability arising out of the provision of this Service. The User agrees and acknowledges that he/ she shall be solelyresponsible for his/ her conduct and that M/s.Kalyan Resortsreserves the right toterminate the rights to use of the Service immediately without giving any prior notice thereof.
- 2. M/s.Kalyan Resortsand/or the Payment Service Providers shall not be liable for anyinaccuracy, error or delay in, or omission of (a) any data, information or message, or (b) thetransmission or delivery of any such data, information or message; or (c) any loss or damagearising from or occasioned by any such inaccuracy, error, delay or omission, non-performanceor interruption in any such data, information or message. Under no circumstances shall theM/s.Kalyan Resortsand/or the Payment Service Providers, its employees, directors, andits third party agents involved in processing, delivering or managing the Services, be liable forany direct, indirect, incidental, special or consequential damages, or any damages whatsoever,Including punitive or exemplary arising out of or in any way connected with the provision of orany inadequacy or deficiency in the provision of the Services or resulting from unauthorizedaccess or alteration of transmissions of data or arising from suspension or termination of theservices.

- (I) the delay, failure, interruption, or corruption of any data or other information transmitted inConnection with use of the Payment Gateway or Services in connection thereto; and/ or

- (ii) Any interruption or errors in the operation of the Payment Gateway.
- 4. The User shall indemnify and hold harmless the Payment Service Provider(s) M/s.Kalyan Resortsand their respective officers, directors, agents, and employees, from anyclaim or demand, or actions arising out of or in connection with the utilization of the Services.
- 5. The User agrees that M/s.Kalyan Resortsor any of its employees will not be held liable bythe User for any loss or damages arising from your use of, or reliance upon the information contained on the Website, or any failure to comply with these Terms and Conditions where such failure is due to circumstance beyond M/s.Kalyan Resortsreasonable control.

Although all reasonable care has been taken towards guarding against unauthorized use of any information transmitted by the User, M/s.Kalyan Resortsdoes not represent orguarantee that the use of the Services provided by/ through it will not result in theft and/orUnauthorized use of data over the Internet.
- 4. M/s.Kalyan Resorts, the Payment Service Provider(s) and its affiliates and associatesshall not be liable, at any time, for any failure of performance, error, omission, interruption, deletion, defect, delay in operation or transmission, computer virus, communications linefailure, theft or destruction or unauthorized access to, alteration of, or use of information on the Website.
- 5. The User may be required to create his/ her own User ID and Password in order to registerand/ or use the Services provided by M/s.Kalyan Resortson the Website. have been completed. This is to ensure thatothers cannot access the User's personal information and correspondence when the Userhappens to share a computer with someone else or is using a computer in a public place like alibrary or Internet café.

E. Debit/Credit Card, Bank Account Details

- 1. The User agrees that the debit/credit card details provided by him/ her for use of the aforesaidService(s) must be correct and accurate and that the User shall not use a debit/ credit card,that is not lawfully owned by him/ her or the use of which is not authorized by the lawful ownerthereof. - iv. The User is responsible to ensure sufficient credit is available on the nominated card/bank account at the time of making the payment to permit the payment of the duespayable or the bill(s) selected by the User inclusive of the applicable Fee.

F. Personal Information
